Kindergarten Readiness

Fall 2019 marks the first data collection period for statewide implementation of the Virginia Kindergarten Readiness Program (VKRP). VKRP is redefining the discussions surrounding and data available on "Kindergarten Readiness" to better reflect research in early childhood success.

In prior years, children have been assessed on early literacy via Fall administration of the Phonological Awareness Literacy Screening (PALS). Students who achieve proficiency on PALS were thus considered "Ready for Kindergarten." In addition to PALS, VKRP incorporates two additional assessments: The Early Mathematics Assessment System (EMAS) and the Child Behavior Rating Scale (CBRS). Teachers administer PALS, EMAS, and CBRS in the Fall and Spring, and students are scored in the domains of Literacy, Math, Social Skills, and Self-Regulation.

To be considered "Ready for Kindergarten" via VKRP, a student must meet or exceed benchmarks in all four domains.

Statewide rollout of VKRP represents major changes to both the availability of population-level data related to social-emotional learning and the ways in which we evaluate early childhood education and opportunities. Consider the results showing how 88.0% of all Kindergarten students in Virginia Beach City Public Schools met Fall 2019 PALS proficiency benchmarks. In prior years, our knowledge of Kindergarten Readiness would have stopped here. However, the newly adopted VKRP measurements in Math, Social Skills, and Self-Regulation, suggests just 53.8% of students are considered to have arrived "Ready for Kindergarten" across all four domains.
